It is our passion, goal, and objective, building on more than 9 years of experience and a hard-earned reputation as a professional, responsive organization that is accountable and focused on what matters.

Our work is set within the overall ambition of **HEAL Inc.**'s Mission and Vision, and we do this by targeting the most vulnerable communities, and those in extreme poverty, especially those residing in the rural area. The plan presents an ambitious vision for even greater impact by establishing a permanent campus for our orphans, creating a profitable business to sustain the orphanage, and targeting female adult orphan to learn make dominated vocational scales.

**Our focus**: Remains resolute on providing services to people living below the poverty threshold, and vulnerable orphans.

Child-centered programming: Drawing on our long-standing commitment to high-quality education, we will ensure vocational and life skills as part of a robust capacity building at the orphanage to prepare them for the real world.

**Hope:** Global positioning to influence change at the level of communities we work in, with a primary focus on providing a reason to be a good citizen.

### FINANCIAL HIGHLIGHTS

### OPERATING HIGHLIGHTS

During the period under review, HEAL Inc. funded several renovation and WASH projects including latrines, homes, sponsored 35 students in school, provided emergency supplies, and household items and completed the following projects.

1.In partnership with Orphan Concerns we funded and completed the following projects

- A. **El-Shaddai Orphanage**, Liberia (32 Orphans)
- Restroom added three additional stalls and renovated the entire 6 stalled restrooms

#### B. Sis Iye Orphanage, Liberia (40 Orphans)

- Playground renovated a playground that provides leisure time activities for the orphans and the community
- C. Implemented the Adult Orphan Education Initiative by sponsoring two females at a vocational institution. Jubilee Ministries Orphanage, Liberia
  - 2. In partnership with Jubilee Ministries, we adopted the orphanage and provide the following:

Liberian Christian Orphanage, Liberia (23 Orphans)

Education – 23 orphans are enrolled in school

- Nutrition provides daily meal
- WASH provide hygiene products, safe drinking water, and a functional restroom
- Maintain the campus and provide stipend to care takers.
- 3. Disaster Relief
- ATL for Haiti received over \$10,000 worth of hygiene products, food, clothing and medical supplies in response to the disaster in Haiti
- 4. Livelihood
- Renovated a home for two disabled individuals.

### LOOKING AHEAD

As we start the new year, we are excited that we can help and change the lives of people. We have developed an elaborate and ambitious budget that seeks to purchase the campus to give the orphans a permanent home, the campus is to be purchased at \$25,000. It is currently valued at \$38,000. We intend to renovate the buildings, fence the campus, and introduce self-sustaining activities such as building affordable homes for lease, a poultry, raising livestock, and enhanced the garden. The provision of electricity is also a milestone we want to reach as soon as the purchase of the campus is completed.

## **ONGOING PROJECTS**

- Quarterly supply of hygiene products, and other basic essentials
- Providing daily meals to the orphans Sponsoring 35 Students from elementary to high school, including 2 students in vocational school
- Providing medical supplies and medication to a partner with mobile clinic to treat our orphans
- Adult Education Vocational Training



### FINANCIAL SUMMARY

During the period under review, **HEAL Inc.** raised Forty-Eight Thousand, Six Hundred Ninety-Five Dollars, and Twenty-Seven Cents (**US\$48,695.27**) this amount includes contributions from partners, business organizations, and individual donors. Mercedes Benz remains the biggest contributor to **HEAL Inc.** with 42.7% followed by the restricted funds received for the purchase of the campus at 23.5% and the rest from individual donors. This income is deposited into the organization's accounts in the United States and later wired to Liberia for the operations of the organization.




## **EXPENSES**

The expenses for the same period amounted to Forty-One Thousand, Forty-Seven Dollars, and Twenty-One Cents (\$41,047.21) As stated, most of the funds were used for direct impact programs and operations. The organization expended 24% of the funds for the campus purchase, 22% paid to Triple AAA service for operation our concession stand at Mercedes Benz, 16% on education, 18% on food & nutrition, 4% for staff, 7% on WASH and projects carried out by local partners, and 3% on admin cost.
